#### 2017-2018 Indoor Pool Swimming Rules - Labor Day to Memorial Day

## 1. HOURS

- **a.** 5:00 AM to 11:00 PM daily for all residents **and accompanied adult guests (18 years of age or older.**
- **b.** Children are allowed on weekends from 11:00 AM to 3:00 PM and on specially designated holiday days or weeks.
- **c.** Residents have access to a lap lane with adaptable rope when conditions warrant the use of a designated lane. Ask Management or a Pool Committee member for details.

#### 2. IN GENERAL

- **a.** No children under the age 18 are allowed in the spa.
- **b.** Children may use swimming aids but no rafts or large inflatable toys are permitted.
- **c.** Residents must always be in close proximity to children under their care and insure that they are supervising children to comply with these rules.

#### 3. GUESTS

- **a.** Guests must be accompanied by a resident at all times in the indoor pool area, no exceptions.
- **b.** Children must be supervised by an adult when using the locker room/rest room area.

#### 4. RESPECTING OTHERS

- **a.** Children in diapers, pull-ups, etc. are not allowed. All children must be toilet trained before they can use the pool. Adults in any kind of diaper are not permitted either.
- **b.** SHOWER BEFORE ENTERING THE POOL ENVIRONMENT.

# (Requirement of the New Jersey State Sanitary Code)

c. Resident must clean up before leaving. Receptacles are available for trash and lost and found.

## 5. NOT ALLOWED

- a. DIVING or JUMPING
- **b.** RUNNING or HORSEPLAY
- c. BALL PLAYING OF ANY KIND IN INDOOR POOL
- **d.** DOGS OR OTHER ANIMALS (Exception guide dogs)
- e. SITTING ON THE STEPS LEADING TO EITHER POOL OR SPA

### 6. LIABILITIES

- **a.** The rules of the Board of Health and the State Sanitary Code will be observed and followed at all times
- **b.** These rules are posted just outside the entrance to the pool area.
- c. Person suspected of being under the influence of alcohol or drugs will be prohibited.
- **d.** Any resident or their guests whose actions cause the pool to be drained will be fined all costs.
- **e.** A "No Lifeguard on Duty" sign will be posted. Residents and guests swim at their own risk. The Board of Health exemption from having lifeguards is based on a policy of swimmers not swimming alone (buddy system).
- **f.** Spa use Hot water can cause health risk hazards including elevated blood pressure. If you think you may be at risk by using the spa, please consult with your physician before doing so.
- **g.** Indoor bathing shall be <u>discontinued during electrical storms</u> and the pool areas cleared and remain cleared for up to 30 minutes after the last sound of thunder is heard.

## 7. MISCELLANEOUS

- **a.** Wet bathing suits and bare feet are not allowed on the main floor level of the clubhouse.
- **b.** Cover-ups, shirts and footwear must be worn in the main floor level at all times.
- **c.** Our pool management company, Candlewood Mgt. Svc., is responsible for the maintenance and testing of the pool and spa.

### 8. OVERALL

- **a.** Rules are for your protection and are necessary to promote safety and courtesy.
- **b.** Violators of the rules run the risk of losing their pool privileges.
- **c.** We are counting on your cooperation to provide a safe, secure area of enjoyment for everyone.
